sir,

With reference to your application Dated 9-3-90 on the subject cited above, I am directed to convey the permission of the Director of Education, Delhi to your society to establish school from class Ist to VIII (Without aid) in Hospital Road, Jangpura, New Delhi-14 area of district South subject to the Epllowing conditions:

- That the provisions of BSEAR, 1973 and the rules framed there under shall be observed by the society.
- That the management of the school will fulfil all the conditions laid down under Rule 50 and will provide all the facilities given in Rule 51 of DSER, 1973 to the 2. institution.
- That the management of the school will get the scheme of management approved from the department immediately. 3:
- That only qualified and trained teachers will be appointed 4 . at prescribed Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheque.
- That the management of the school will not ask for grant-5. in-aid from the department.
- That in case at any time the management of the school 6. is unable to run the school moveable and non-moveable property of the school will be transferred in the name of Director of Education, Delhi.
- That the school will not run for the profit of any 7. individual association or group of persons.
- That the management of the school will apply for grant of recognition of the school under DSEA and Rules, 1973 separately and recognition will not be granted unless statutory provisions of Section 4(i) (a) to (f) read with rules 50 and 51 are fulfilled with rules 50 and 51 are fulfilled.

- 9. That all the recognised classes shall be run at one place
- That the school shall be run under the control of Delhi Diocesan Trust Association Society (Regd.), Delhi and suitable funds will be made available for the constructions of suitable building on the land allotted to the society, as declared as per the specifications of the department within a period of 3 years and adequate and sufficient accommodation of 12 sq. ft. per student shall be provided for class-room. The normal size of the class room is 24' x 20'. No other activities other than education shall be run. 10.

If recognition for the proposed school is not sought after fulfilling all the above conditions within a period of 3 years, this permission to run a school shall be treated as cancelled.
